For fiscal year 1908, a similar statement for the Department of Agriculture (exclusive of Forest Service) forms a part of the document bearing title Combined report of expenditures during fiscal year 1908, appropriations for fiscal year 1909, and expenditures proposed for fiscal year 1910, for which see [5484-1221]. Expenditures for fiscal year 1909 appear also in a document of the next year with similar title, for which see [5774-421].
