## C12. SHIPPING COMMISSIONERS

[Act of June 7, 1872, authorized the appointment of Shipping Commissioners by the several circuit courts. Act of June 26, 1884, changed the control of the Shipping Commissioners from the circuit courts to the Treasury Department, which control was exercised by the Navigation Bureau. July 1, 1903, they were transferred to the Commerce and Labor Department. No publications were issued under the Treasury Department.]
