J6. PENITENTIARY, FORT LEAVENWORTH

[Established by act approved Mar. 3, 1895 (Stat. L. v. 28, p. 957), taking effect July 1, 1895. In the first report (J6.1:896), the warden states as follows: "By act of Congress the Fort Leavenworth Military Prison was abolished June 30, 1895; the control of the property was transferred from the War Department to the Department of Justice, and by the same act the United States Penitentiary came into existence July 1, 1895. By operation of law the officers and guard of the Military Prison were continued in charge of the Penitentiary until the Attorney-General could appoint and commission civil officials. The transfer from the military officials to the civil officials occurred Sept. 1, 1895. On that date, as warden I took charge of the Penitentiary."]
